

The following promotion is intended for participants in the United States only, and will be governed by United States laws. **B96 DISNEY CRUISE GIVEAWAY
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE ENTRANT'S CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the B96 Disney Cruise Giveaway promotion ("Promotion"), which is being conducted by WBBM-FM, B96 Radio ("Station"). The Promotion begins on Monday, November 13, 2017 and ends on Friday, November 17, 2017 ("Promotion Dates").
- b. To enter the Promotion, entrant may enter by phone beginning on Monday, November 13, 2017 at 12:00pm Central Time ("CT") and ending on Friday, November 17, 2017 at 1:00pm CT ("Entry Period").
 - i. To enter on-air, listen to the Station each weekday beginning on Monday, November 13, 2017 and ending on Friday, November 17, 2017 between the hours of 12:00pm CT and 1:00pm CT for the announcement of the cue to call. Upon hearing the cue to call, the twelfth (12th) caller to get through to the Station contest line at 312-591-9696 will win a qualifying prize and will be qualified for a chance to win the grand prize, upon confirmation of eligibility. At the time of entrant's call, entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted. In the event that the selected caller is disconnected, or is found to be ineligible, the next eligible caller who successfully makes it through on the call-in line, and completes the call will be a qualifying prize winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a qualifying prize winner only once.
- c. There will be up to a total of five (5) qualifying prize winners and one (1) grand prize winner selected in the Promotion.
- d. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests. Entrants are encouraged to listen to the Station on-air. The Station is not responsible for online streaming delays of any nature.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are legal U.S. residents 21 years of age or older at time of entry and who reside in Illinois, Indiana, or Wisconsin. Void everywhere else and where prohibited or restricted by law. Employees, officers, directors and agents of Disney Destinations, LLC, the Station, CBS Radio Inc., each of their respective parents, subsidiaries, and affiliates, the Station's advertising and promotion agencies, and participating sponsors or prize suppliers (collectively, the "Promotion Entities") and other radio stations in the Station's market, the members of their immediate families (spouses, parents, children, and siblings, regardless of where they reside) and those living in the same household of each (whether related or not), are ineligible to enter or win. This Promotion is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects, and entrant agrees to waive any right to claim ambiguity in the Promotion or Official Rules, except where prohibited by law.

- b. Only one (1) winner per household.
- c. The winners must provide valid government-issued photo identification and provide their complete address, date of birth and phone number to claim a prize(s).
- d. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.

3. PRIZES

- a. Up to five (5) qualifying prizes will be awarded in the Promotion. Each qualifying prize consists of a two hundred dollar (\$200) Disney Gift Card. The Approximate Retail Value ("ARV") of each qualifying prize is \$200. Each qualifying prize winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the qualifying prize. The qualifying prize is awarded as is. The gift cards will be subject to the terms and conditions as set forth by the issuer of the gift cards. Gift cards are not refundable or transferable, and may not be substituted or exchanged for cash or credit at any time, nor will gift cards be replaced if lost or stolen. The Disney gift card is valid only at select participating locations, and is subject to additional terms and conditions. Gift cards have no expiration date.
- b. Up to one (1) grand prize will be awarded in this Promotion. The grand prize is a trip for four (4) people (grand prize winner and three (3) guests) for a four (4) night Bahamian Disney Cruise Line Vacation. Grand prize trip includes the following:
 - (i) Room accommodations of one (1) stateroom aboard the Disney Dream (with a maximum of four (4) people per cabin) including all meals (alcoholic beverages not included) aboard the cruise ship (excluding meals at Palo and Remy restaurants).
 - (ii) Round-trip coach airfare vouchers for up to four (4) people between a major airport near the grand prize winner's home to Orlando International Airport. Each passenger will be responsible for applicable travel taxes.
 - (iii) One (1) voucher for roundtrip ground transfers for up to four (4) people to/from the Orlando International Airport and Port Canaveral.
 - (iv) Pre-paid gratuities and select government taxes, fees, and port expenses (as defined on the Disney Cruise Line website)

ARV of the grand prize is \$8,379.32.

Actual value may vary based on point of departure and dates of booking and travel. Any difference between stated value and actual value, if any, will not be awarded. Certain travel and cruise line restrictions may apply. Travel arrangements must be made through Disney. Grand prize is subject to availability. If the winner(s) cannot travel on date(s) specified by the Station, the winner(s) may be disqualified, and an alternate winner(s) may be selected (time permitting) at the Station's sole discretion. All other costs not specifically stated herein, including but not limited to those of taxes, applicable fees, service charges, surcharges or passenger facility charges, meals, any hotels, entertainment and other activities, parking, taxes, shore excursions, travel insurance; nursery charges; laundry services; spa treatments, alcoholic beverages; local and long distance telephone calls; ship-to-shore communications including internet, merchandise and souvenirs; specialty food & beverage items; incidental expenses; additional tips and gratuities; income and other taxes; transportation between winner's home and gateway airport, are the responsibility of the winner(s). Travel must be round trip. Station will determine itinerary and airline, if applicable, in its sole discretion. The Station reserves the right to structure the travel route in their sole discretion. Prize trip may not be combined with any other offer and travel may not qualify for frequent flyer miles or loyalty programs. Promotion Entities will not replace any lost or stolen tickets, travel vouchers, or certificates. The winner(s) and guest(s) must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without

limitation, valid photo ID (or valid passport(s) for international travel). Airline and cruise line regulations apply. If applicable, the winner may be required to present a valid credit card upon check in to cover any incidental expenses incurred during the winner's stay. The winner(s) and guest(s) must sign a Publicity, Liability Waiver and Travel Release form prior to traveling. Complete terms and conditions of travel may be furnished with prize notification and/or further correspondence. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Promotion Entities, their sole responsibility to the winner(s) will be to award the remaining available elements of the grand prize(s) and no substitution or compensation will be provided for the unawarded elements of the grand prize(s). No compensation will be made in the event of the cancellation or delay of any transportation. The Station and/or cruise ship, in its sole discretion, reserves the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize related event(s).

Minors under the age of 18 not traveling with a parent or legal guardian must be accompanied by an adult over the age of 21 in the same stateroom. Grand prize winner must booked at least forty-five (45) days or more prior to the intended travel dates and must be taken prior to January 15, 2019 aboard a Disney Cruise Line Ship departing from Port Canaveral (at the discretion of Disney Cruise Line Vacations). - c. No more than the stated number of prizes specified in these official rules will be awarded. All prizes or prize certificates must be claimed at the office of the Station at the address below during regular business hours. The winner(s) will forfeit any prize(s) or prize certificate(s) not claimed within ten (10) days of winning. Unless otherwise specified or required by law, if a prize is not claimed no alternate winner will be selected and the prize will become the property of the Station. The Station may opt to deliver the prize to the winner by mail or overnight courier solely at its discretion. In the event that the Station delivers the prize to the winner by mail or courier with the winner's consent, the winner assumes the risk of the prize's loss, damage or delay.
- d. Prize(s) is not transferable, and no substitution, assignment or cash equivalent of prize(s) is permitted, except by the Station (solely at its discretion), which reserves the right to substitute a prize or prize portion with another prize or prize portion of greater or equal value. The prize(s) are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Promotion Entities are not responsible for winners' limitations that prevent acceptance or use of prize(s). The Prize(s) is provided as is. Entrants acknowledge that the Promotion Entities have not made, and are not in any manner responsible or liable for, any warranties, representations or guarantees, and hereby disclaim any and all warranties, expressed or implied, whether by contract or law, concerning any prize, including without limitation, implied warranties of quality, merchantability, mechanical condition or fitness for a particular purpose, with the exception of any standard manufacturer's warranty that may apply. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Promotion are final.
- b. Up to five (5) qualifying prize winners will be selected by the Station on-air in the manner described in Section 1 of these official rules. Potential qualifying prize winners will be notified at the time of their winning call.
- c. Up to one (1) potential grand prize winner will be selected at approximately 3:00pm CT on Friday, November 17, 2017 in a Station-conducted random drawing from among all qualifying prize

winners selected during the Entry Period. Potential grand prize winner will be notified of winning by email and/or telephone promptly following the drawing.

- d. Odds of winning a qualifying prize depend on the number and order of calls received. Odds of a qualifying prize winner winning the grand prize are up to 1 in 5.
- e. Entrants must listen to the Station to win a qualifying prize but need not be present to win a qualifying prize. Qualifying prize winners need not listen to the Station or be present to win the grand prize.
- f. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. - b. Participation in the Promotion and/or acceptance of prize(s) constitutes entrant's and/or winner's (and guest's, if applicable) permission for the Station or its designees to interview the winner(s) (or guest(s), if applicable), to photograph, film and record each winner (or guest, if applicable), and to use in commerce, advertising and in any media, now or hereafter known, throughout the world, in perpetuity, his/her name, prize(s) won, hometown (city and state), biographic information, likeness, photograph, voice, audio or video recording and/or any statements made by him/her regarding the Station, the Promotion and/or its sponsor(s) for purposes of trade, publicity or promotion without notice or additional compensation, notification or permission, except where prohibited by law. Each winner (and guest, if applicable) agrees to sign a publicity release confirming such consent prior to acceptance of the prize, except where prohibited by law.
- c. - d. If for any reason this Promotion cannot be executed as planned, including but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Released Parties that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend and/or modify the Promotion. If the Promotion is terminated before the original end date, the Station reserves the right, in its sole discretion, to modify the procedure for selecting winner(s), unless the nature of the event giving rise to such termination renders it impossible to select winner(s).
- e. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize(s); (ii) incorrect or inaccurate entry information, human error, failure or omission; (iii) unauthorized human intervention; (iv) lost, stolen, mangled, misdirected, postage due, illegible, incomplete, unsuccessful, or late entries or notifications; (v) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, telephone or text message service outages, delays, busy signals, poor signals or signal interference, accidental disconnection or equipment malfunctions or any other technological problems or failures of any kind; or (vi) any cancellations, delays, diversions, substitutions or omissions whatsoever by any transportation providers or any other persons or entities providing any services to winner(s) (and guest(s), if applicable) including any results thereof such as changes in services or location necessitated by same. Further, the Released Parties are not responsible if any part of a Promotion prize cannot be awarded due to acts of God, acts of war, natural disasters, weather, acts of terrorism or other factors beyond the Released Parties' control.
- f. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins or any other methods may void that entrant's entries and that entrant may be disqualified. The use of any device to automate entry is prohibited. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, promotion entry services or proxies) will void all entries by that entrant at the Station's discretion. The Station's or its Promotion administrator's computer or telephone system is the official time keeping device for this Promotion. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address or (ii) is assigned to the text or mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Promotion. Failure to comply with the rules of the Promotion may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station may disqualify that entrant from entering and/or winning this and any or all future Station-administered Promotions and seek damages to the fullest extent permitted by law.
- g. The Station reserves the right to modify these rules for clarification or equitable purposes without materially affecting the terms and conditions of the Promotion, including, without limitation, the substitution of a prize(s) of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Promotion Entities, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to cancel, terminate, suspend or modify the Promotion and shall not be required to award a substitute prize(s). If any provision of these Official Rules is irrevocably inconsistent with any provision set forth on the Contest webpage, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.

- h. Except where prohibited, by entering the Promotion, each entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize(s) awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in New York, NY; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event shall such costs include attorneys' fees; and (3) no punitive, incidental, special, consequential or other damages, including, without limitation, lost profits may be awarded (collectively, "Special Damages"), and (4) entrant hereby waives all rights to claim Special Damages and all rights to have any damages awarded multiplied or increased.
